## TUITION ASSISTANCE INFORMATION

Tuition assistance at the Rockland Conservatory of Music is based on financial need and is subject to availability of funds. This application form, proof of income, registration form, registration fees (\$30 per family) and 10% of total registration are required. Confidentiality will be maintained. Below are the expectations for all students receiving financial aid.

- 1. **Punctuality**: The time spent with your teacher is valuable. If any student is unable to attend a lesson, the office must be notified by 12:00 noon on the lesson day or 8:00 am for Saturday lessons to qualify for a make-up lesson. There are two make-ups per year. Tuition assistance must be allocated where it is needed most, so if you are absent <u>without notice</u> more than twice, your aid may be withdrawn.
- 2. **Practice:** In order to progress, practice time must be set aside. While the focus is not ultimately on a high level of musical ability, it's important that all students show growth and improvement and a great level of commitment.
- 3. **Participation:** Your help enables the school to offer tuition assistance. Due to the great number of students applying, those students and families who receive financial assistance are required to become co-operative partners with the school and are asked to take part in school activities, volunteering at special events and active involvement in performance classes and recitals. Please sign up for your volunteer hours at the time of your interview.
